

## OVERVIEW

The final open house and public hearing were held to gather public input on plan priorities, and to provide a public forum for questions or comments related to the plan. The open house was held from 5:30 p.m. to 7:30 p.m.. The public hearing was held at 6:00 p.m. Mike Nuvalle of the Office of Community Development moderated the hearing, while Mayor Alcombright provided an introduction to the plan and its significance for the future of North Adams. BRPC Senior Planner and Project Manager Amy Kacala walked attendees through the planning process, the elements of the plan, and the five priorities of the plan. North Adams City Planner Mackenzie Greer walked attendees through the implementation phase of the plan—how that will look and happen. She highlighted a number of policies or actions that are happening or have happened during the course of the plan’s development. Approximately 40 members of the public attended.

## OPEN HOUSE

In the Open House, attendees were invited to look at two sets of posters. The first set composed an executive summary of the plan, including an introduction to the plan, the vision developed during planning process, and the five key priorities and priority topics by plan chapter. The executive summary style posters for each chapter allowed participants to see what sort of process went into gathering information and developing goals, policies and actions, and also to see the goals from each section. The second set of posters consisted of the five plan priorities:

### **1. Economic Renewal**

### **2. Physical Reinvestment**

### **3. Thriving, Connected Community**

### **4. Intergenerational Thinking**

### **5. Fiscal Efficiency**

Three to ten priority policies were selected by priority work area, as identified by staff and members of the steering committee. Each participant was given twelve blue dots. These dots represented the limited resources with which implementation must be conducted. Attendees were told to allocate their blue dots to the policies they found most important. ## PUBLIC HEARING

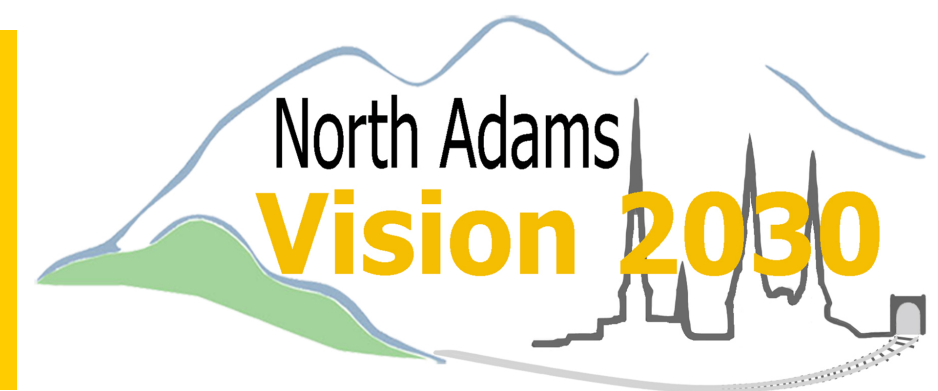
The public hearing lasted approximately forty-five minutes. The following comments were provided by attendees:

- The priority should be on improving aesthetics and function of the corridors and gateways and providing access to the River as a resource.
- One attendee inquired about who would oversee the plan and if it would supercede other boards and commissions. Michael Nuvalle responded that the plan is overseen by the Office of Community Development and that it does not take away the roles and responsibilities of any boards and commissions.
- One attendee noted the importance of benchmarking and measuring success as part of the planning process.
- One attendee spoke as a representative staff member of the Northern Berkshire Community Coalition. They participated in many sections of the plan, worked on connecting with neighbors and see the agency as an implementing partner. Annie encouraged other volunteers to step up and participate in their neighborhood work
- One attendee noted the importance for intergenerational representation on the implementation committees.
- One attendee asked for concrete examples of activities implemented that she and others can point to when community members ask about the plan. The list of actions to date was displayed again and some discussion was had.
- Judy Grinnell, in response to the first comment, described the actions of the Hoosic River Revival.
- One attendee noted that this plan is a long time in coming and encouraged community members to step up and take action.
- The final comment made: an attendee noted how happy she was to learn that the Cemetery Commission has been “resurrected” and asked that others help the Commission to better care for these community resources.

- Utilize areas of the river and adjacent areas to support social interaction and health activity.

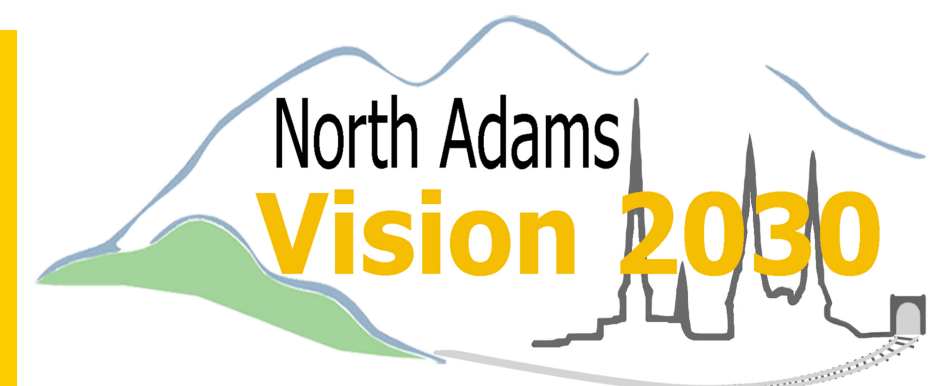
